MEMORANDUM OF UNDERSTANDING

BETWEEN

UNIVERSITAS NASIONAL

INDONESIA

AND

NITTE MEENAKSHI INSTITUTE OF TECHNOLOGY

INDIA

THIS MEMORANDUM OF UNDERSTANDING (MoU) is made

BETWEEN

Universitas Nasional, Indonesia with the registered address at Sawo Manila, Street, #61, Pejaten, Pasar Minggu, Jakarta 12520, Indonesia, hereinafter referred to as "UNAS";

AND

Nitte Meenakshi Institute of Technology Bangalore India, with the registered address at P.B.No.6429. Yelahanka 560064, Bangalore, India, hereinafter referred to as "NMIT".

Preamble

UNAS and NMIT shall hereinafter be referred to as the "Parties."

WHEREAS, the Parties hereto desire in order to promote cooperation and advancement of academic and educational collaboration;

WHEREAS, the Parties have expressed the interest to form a mutually beneficial academic partnership to further enhance the services given to its students, faculty members, and partners through the said partnership;

NOW THEREFORE, the Parties agree to the following terms and conditions:

1.0 PURPOSE

- 1.1 To promote academic cooperation through joint research and study in the furtherance of advancement of learning;**
- 1.2 To encourage visits by faculty members from one Faculty to the other for the purpose of engaging in research;**
- 1.3 To encourage visits by students from one Faculty to the other for the purpose of academic exchange program;**
- 1.4 To foster the exchange of scientific materials, academic publications and scholarly information; and**

1.5 Other forms of cooperation which the Parties may jointly arrange. Prior to the implementation of each initiative in this category, a formal agreement between the Parties outlining all detailed arrangements including the full financial responsibility shall be duly executed.

2.0 ROLES AND RESPONSIBILITY OF UNAS AND NMIT

2.1 The Parties acknowledge that visits by students and faculty members from one University to the other shall be subject to the entry and visa regulations of Indonesia and India and shall comply with the regulations and policies of UNAS and NMIT;

2.2 The Parties agreed that all expenses including research materials, domestic travel claims, honoraria and all other expenses, shall be the responsibility of the home university and determined on a case-by-case basis. However, each Institution will strive to facilitate the visits of faculty members for the purposes of collaboration.

3.0 TERMINATION

The MoU may be terminated by either party upon giving six (6) month's written notice.

4.0 DURATION AND EXTENSION

This MoU shall be for a period of five (5) years with effect from the year 2020 and will be extended automatically following the expiration date for another year unless the Parties dissent from the extension of the agreement six months prior the expiration date.

5.0 GOVERNING LAW

The laws applicable in both countries (Indonesia and India) govern this MoU and the Parties submit to the jurisdiction of the courts of this jurisdiction.

6.0 ASSIGNMENT

A Party must not assign this MoU or any right under this MoU without the prior written consent of the other party.

7.0 NOTICES

All notices and other communications which are required or may be given under this MoU shall be given in writing in accordance to the required time or sent by electronic mail of telefax or delivered by hand to the other party at the address as specified below and shall unless otherwise specifically provided herein, be deemed to have been given or made on the date of receipt by the other party;

8.0 FORCE MAJEURE

The Parties shall not be liable for breach of any provisions of this MoU caused by an Act of God, riot, Civil commotion, war or military operation, emergency or any action by government of the authority, industrial, disputes, fire explosions, flood, had weather or any similar cause or circumstances beyond the reasonable control of either party.

9.0 COSTS

The Parties agree to bear their own legal and other cost incurred in relation to the preparation, negotiation and execution of this MoU and all documents contemplated

by it (except where this MoU or those other documents expressly provides to the contrary).

10.0 VARIATION

Any variation, amendment, addition or deletion of any of the terms and conditions of this MoU is only valid if made by mutual consent of the Parties and it should be put in writing.

11.0 LANGUAGE

This MoU shall be prepared in English and Indonesian language, for two (2) copies of equal validity and in the event of conflict or misinterpretation, the English version shall prevail. One (1) copy will remain in the possession of each of the Parties.
